Joining Forces with Civil Society for Lasting Change

To empower disadvantaged groups to confidently engage with the legal system and share their knowledge within their communities, JSSA, through its partner Street Law, Inc., has hosted a series of Legal Life Skills training-of-trainers sessions. These sessions focused on essential legal literacy and facilitation skills, equipping participants to serve as advocates and educators in their local areas.



Over **60 activists and CSO leaders** have been trained as Community Trainers in Legal Life Skills, covering topics such as citizens' roles and responsibilities, marriage and divorce, domestic violence, disability rights, labor contract provisions, and the rights and responsibilities related to property ownership and housing



These trainers conducted 31 follow-on sessions on topics such as disability rights, domestic violence, and property rights, reaching 917 individuals (718 women and 199 men) by September 2024.



Facilitated the creation of training teams comprising judges and CSO representatives, a pioneering initiative in Uzbekistan.

Innovative Judge-CSO Partnerships



These teams have delivered over 15 trainings on gender equality and combating gender-based violence for judges across the country.

29 gender officers among judges of regional courts were appointed to champion gender sensitivity in court processes



Championing Change Through Gender Officers

Two comprehensive training programs delivered:

- “Training of Trainers” module for newly appointed gender officers;
- Gender Mainstreaming in the Judiciary for acting judges
