KEVIN J. JD, MSJA, CCE, ICM Fellow, is a certified Court Executive and currently serves as Chief Administrative Officer of the International Association for Court Administration. He previously worked as Trial Court Administrator and Attorney Referee in Michigan and is a Past President of the National Association for Court Management, and former Chair of the U.S. Department of Justice Global Advisory Committee. His career in the judiciary spans more than 45 years, including service as a court administrator, attorney, judicial educator, consultant.

Mr. Bowling holds degrees in political science/public administration, judicial administration, and law, and is a Fellow of the Institute for Court Management. He is a member of the State Bar of Michigan and several professional judicial associations.



Michael Navin is a Principal Court Management Consultant at the National Center for State Courts (NCSC), where he leads technology-focused initiatives within the Technology, Architecture, Planning, and Security Division. With more than 20 years of experience in court administration, he specializes in integrating emerging technologies—particularly AI—into judicial operations to improve efficiency, access to justice, and public trust.

Since joining NCSC in 2023, he has led national AI strategy and readiness projects, developed governance frameworks, and advised courts on scalable “AI First” initiatives. He holds a B.S. in Criminal Justice and Psychology from Wayne State University and is a certified AI Governance Professional (AIGP).



Rasim Babanly serves as Acting Chief of Staff of the Supreme Court (Ukraine). Prior to his appointment, he worked as First Deputy Chief of Staff and headed the Department of Analytical and Legal Work of the Supreme Court. He holds a Doctor of Laws degree and has occupied senior leadership positions in courts of cassation since 2013.

Mr. Babanly remains responsible for the analytical support function of the Supreme Court, including cooperation with other public authorities, Council of Europe institutions. He represents the Supreme Court in the European Court of Human Rights’ Network of Superior Courts and in the parallel network established by the Court of Justice of the European Union. He is also the initiator of the Supreme Court’s Database of Legal Positions and continues to lead its development and modernization.



Ken Hwee Tan serves as Chief Transformation and Innovation Officer (Judiciary) at the Supreme Court of Singapore, where he oversees transformation, digitalisation, innovation, and technology strategies across the Supreme Court, State Courts, and Family Justice Courts. He leads the Judiciary’s “Courts of the Future” workplan and has contributed to major law reform initiatives.

Previously, he was Chief Prosecutor of the Financial and Technology Crime Division at the Attorney-General’s Chambers, handling complex white-collar and cybercrime cases. He has also served as Senior State Counsel, Senior Assistant Registrar of the Supreme Court, and Chief Information Officer in both the Attorney-General’s Chambers and the Supreme Court. Involved in legal technology since 1990, he has played a key role in shaping Singapore’s legislative and digital justice landscape.



Bohdan Kryklyvenko is the Chief of Staff of the High Anti-Corruption Court of Ukraine. He holds master’s degrees in law, finance, public administration, and International and European Union law. He began his career in 2005 at the Ministry of Justice of Ukraine, working in the Secretariat of the Government Commissioner for the European Court of Human Rights, where he coordinated the implementation of ECtHR judgments.

From 2012 to 2018, he served as Head of the Secretariat of the Ukrainian Parliament Commissioner for Human Rights. Since June 2019, he has been serving as Chief of Staff of the High Anti-Corruption Court of Ukraine, a specialized court responsible for adjudicating high-level corruption cases.
