**Giuseppe M. Fazari, Ph.D.**, is a professor of criminal justice at Monmouth University and a former chief administrator and court executive for the New Jersey Judiciary. His *Management Musings* column appears quarterly in the National Association for Court Management (NACM), and he is the author of *Courthouse Confidential: Unveiling Lessons Learned in Leading and Managing Trial Court Organizations* (2022). He serves as Regional Vice President of the International Association for Court Administration (IACA). He holds an MPA and a Ph.D. in higher education administration from Seton Hall University and is a Fellow of the Institute for Court Management.



**Carly Schrever, Ph.D.**, is a lawyer, psychologist, and empirical researcher, and Director of Human Ethos with more than 20 years of experience working within the legal profession and courts.

An internationally recognized expert in judicial wellbeing, she has advised courts and legal organizations across Australia, Asia, Africa, North America, the UK, and the Pacific.

Dr. Schrever previously served as the inaugural Judicial Wellbeing Advisor to the Judicial College of Victoria and is currently a Principal Investigator on a national Australian research project examining judicial wellbeing. **Honorable Selena N. Solis** is the presiding judge of the 243rd Judicial District Court in El Paso, Texas.

A Texas native, she earned her B.A. from the University of Texas at Austin and her J.D. from American University Washington College of Law.

Prior to joining the bench in 2018, Judge Solis dedicated her career to public interest law, advocating for low-wage workers, victims of employment discrimination, and low-income immigrants.

She currently serves as a Commissioner on the Judicial Commission for Mental Health and presides over INSPIRE, a problem-solving adult felony mental health treatment court focused on rehabilitation and recovery.



**Tina M. Mattison** is a retired Deputy Court Administrator with extensive experience in court administration across California and Arizona, including leadership roles in Riverside, Orange County, and Pima County courts.

She holds a master's degree in public administration from California State University, Fullerton, and is a graduate of the Institute for Court Management Fellows Program, where she published on vicarious trauma in the courts.
