The 2017 IACA/NACM joint conference took place in July in Washington, D.C. For those of you who missed it, you missed a fantastic conference! The conference was held at the Hyatt Regency hotel in Crystal City, a location very convenient to the Washington airport. To say this sold out conference was large is an understatement – around 800 attendees from more than 40 countries joined together for a week of learning, networking, and, of course, fun.

The conference kicked off with an interesting plenary session panel whose members included Kenneth Benjamin, Chief Justice of the Supreme Court of Belize; John Minton, Chief Justice of the Supreme Court of Kentucky; Mogoeng Mogoeng, Chief Justice of the Republic of South Africa; and MA Yuanjie, Judge of the Judicial Reform Office of the Supreme People's Court. Mary McQueen, a good friend to IACA and the President of the National Center for State Courts served as the panel's moderator. The panel discussed some of today's challenges to the Rule of Law and the independence of the judiciary and the important role court professionals play in advancing the effective administration of justice. It was truly a remarkable occasion to have judicial officers from four continents together on one stage to discuss both special areas of interests as well as common concerns. This was a conference highlight for sure.

The numerous conference breakout sessions had something for everybody and all were well attended. Another conference highlight



that was specific to IACA attendees was the IACA luncheon meeting during which United States Court of Appeals Judge Allyson Kay Duncan spoke. Judge Duncan serves as the current chair of the International Judicial Relations Committee of the U.S. Judicial Conference. She has traveled extensively, speaking and working on topics involving Human Rights law, Counter-Terrorism, Trademark and Copyright Infringement, and Appellate Practice and Procedure. Judge Duncan's comments were heartfelt as she has a passion for international outreach. Judge Duncan welcomed questions and comments from the audience and there was a long line of IACA attendees waiting to speak with her personally immediately following the meeting.

On a more social note, the Tuesday night outing to the Library and Congress was spectacular! The location was breathtaking and the food was outstanding. This was a wonderful time for attendees to network and socialize with each other, as well as visit the many exhibit areas in the Library of Congress. It was a memorable event for all.

Prior to the conference, the IACA Board met to discuss many topics, one being the location of the next IACA conference. President Frietas is working to host the next conference in Iguazú Falls, Brazil in September 2018. More details will be coming as the planning begins for this exciting conference.
